

## **Resolution No. R1-1-26**

### **A RESOLUTION PERMITTING THE SALE OF FERMENTED MALT BEVERAGES IN ASHWAUBOMAY PARK FOR THE 2026 ASHWAUBOMAY FOOD TRUCK RALLIES AND THE ASHWAUBENON BLAST.**

**WHEREAS**, on August 15, 2015, the Citizens of the Village of Ashwaubenon celebrated the 50th anniversary of Ashwaubenon High School by holding the inaugural ASHWAUBENON BLAST celebration; and

**WHEREAS**, by all accounts the ASHWAUBENON BLAST celebration was deemed a great success by the citizens of Ashwaubenon; and

**WHEREAS**, because of said success, there has been an overwhelming response by citizens to continue this and similar types of Village of Ashwaubenon-sponsored events; and

**WHEREAS**, the Village of Ashwaubenon cannot issue a license for the sale of fermented malt beverages to itself;

**NOW, THEREFORE, BE IT RESOLVED**, by the Village Board of Trustees of the Village of Ashwaubenon that the village may sell fermented malt beverages at Ashwaubomay Park for four (4) FOOD TRUCK RALLIES on May 14, June 18, July 16, and September 10 of the year 2026, from 4 pm to 8:30 pm; and at the Ashwaubenon BLAST on August 8, 2026 from 8:00 am – 10 pm, pursuant to Sec. 125.06(6) Wis. Statutes, no license shall be required of said sales.

Any sales made under the provisions of this Resolution shall be made only by the officers, employees or village government designees.

This resolution was adopted by the Village of Ashwaubenon Board on the 27th day of January 2026.
