**ORDINANCE NO. 03-1-25**

**AN ORDINANCE AMENDING CHAPTER 7, ARTICLE 4, SECTION 7-4-100, PARKING  
PROHIBITED AT ALL TIMES, AND REPEALING AND RECREATING, CHAPTER 7,  
ARTICLE 4, SECTION 7-4-102, SPECIAL EVENT PARKING, OF THE VILLAGE OF  
ASHWAUBENON MUNICIPAL CODE**

**THE VILLAGE BOARD OF THE VILLAGE OF ASHWAUBENON DOES ORDAIN  
THAT SECTION 7-4-100 BE AMENDED TO READ AS FOLLOWS:**

**SECTION 1.** Section 7-4-100 Parking Prohibited at all Times

THE FOLLOWING SELECTED ROADWAYS AS SET FORTH IN SECTION 7-4-100 ARE  
AMENDED TO READ AS FOLLOWS:

**Aldon Way North**

Both sides of street, from Aldon Circle to South Broadway.

**North Rd.**

South and east side of road from Cormier Rd to Shady Ln.

**S. Ridge Rd.**

East side of street, from Lombardi Av. to Valley View Rd.

East side of street, from Willard Dr. to 180' south.

East side of street, from Hansen Rd. to 85' south.

East side of street, from Misty Meadow Ln. to 50' north.

**Valley View Rd.**

North of street, from S. Ridge Rd. to easterly end of street.

**Wildwood**

Both sides of street from Myrtle Ln to north end of street.

THE FOLLOWING SELECTED ROADWAYS AS SET FORTH IN SECTION 7-4-100 ARE  
DELETED IN THEIR ENTIRETY:

**THE VILLAGE BOARD DOES ORDAIN THAT SECTION 7-4-102 BE REPEALED AND  
RECREATED TO READ AS FOLLOWS:**

**SECTION 2.** Section 7-4-102 Special Event Parking

(A) No person shall park any vehicle on any street adjacent or near a Special Event or Lambeau Field when parking is prohibited by posted signs that read "No Parking by Police Order" or "No Parking on Packer Game Day."

Subsection (B) shall be deleted in its entirety:

~~(B) For the purposes of this Article, a Lambeau Field Stadium Bowl Event is defined as any event or activity taking place in the stadium bowl of Lambeau Field where the general public is admitted to spectate. Events may include, but are not limited to, athletic games, practices, scrimmages, concerts, entertainment performances or other similar public gatherings.~~

**SECTION 3.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 4.** This ordinance shall take effect upon its adoption and publication.

This ordinance was adopted by the Village of Ashwaubenon Board of Trustees on the 25<sup>th</sup> day of March, 2025.
